

This Carrier Agreement ("Agreement") is made and entered into as of [Date], by and between:

**Broker:** Prime Link Logistics, with its principal place of business at 102 South Tejon Street, Ste 1100, Colorado Springs, Colorado 80903 ("Broker")

## 1. Services Provided

The Carrier agrees to provide transportation services for freight arranged by the Broker in accordance with the terms and conditions outlined in this Agreement.

## 2. Payment Terms (Please Select One)

### 2.1 Quick Pay Option

- **Eligibility:** Carrier may elect to receive payment within 10 business days of the receipt of the invoice and proper documentation.
- **Fee:** A 5% fee will be applied to the gross freight charges for utilizing the Quick Pay option.
- **Process:** To receive Quick Pay, Carrier must submit a complete invoice along with required documentation to Broker. Broker will process the payment within 10 business days, deducting the 5% fee.

### 2.2 Net 30 Option

- **Eligibility:** Carrier may opt to receive payment within 30 days from the date of the invoice.
- **Fee:** No fee will be applied for the Net 30 payment option.
- **Process:** To receive payment under Net 30 terms, Carrier must submit a complete invoice along with required documentation to Broker. Broker will process the payment within 30 days from the date of the invoice.

## 3. Invoicing

Carrier must submit a detailed invoice to Broker, including:

- Carrier's name, address, and contact information
- Broker's reference number
- Description of services provided
- Date of service
- Total amount due

Invoices must be submitted with all supporting documentation, including but not limited to delivery receipts, proof of delivery, and any other required documents.

**4. Documentation**

All necessary documentation required for payment must be submitted by the Carrier within [specified period, e.g., 10 days] of service completion. Failure to provide complete documentation may result in delayed payment.

**5. Dispute Resolution**
